The Philosophy of JULIA KRISTEVA

Julia Kristeva is beyond doubt one of the seminal thinkers of her generation. This volume covers the extraordinary breadth of her work, from linguistics and literature to psychoanalysis, religion, public health, maternity, ethics, and politics. Kristeva has extended semiotics through the notions of intertextuality, dialogism, and semanalysis. She both includes in semiotics the "speaking being" from psychoanalysis and brings the phenomenological idea of Being into the clinic. Her readings of Plato, Hegel, Heidegger, Sartre, and Arendt, among others, enrich the encounters in psychoanalysis and literature across a broad front. Her search for a new humanist vision both keeps a stake in Enlightenment thinkers and redraws the philosophical and psychoanalytic paths of what has come to be known as "negativity," opening up investigations that resonate with the crises humanity is facing in our times. The result is a profound critical analysis of the present whose overall effect is a realignment of the cultural vectors that make up our lives.

The first volume in the Library of Living Philosophers appeared in 1939, the brainchild of the late Professor Paul A. Schilpp, who perceived that it would help to eliminate confusions and endless sterile disputes over interpretation if great philosophers could be confronted on a range of questions by their capable philosophical peers and asked to reply to each of them. As well as the criticisms and replies, each volume would include a photograph, a handwriting sample, an intellectual autobiography, and a complete bibliography of the great philosopher's works.

The Library of Living Philosophers has exceeded even Schilpp's expectations, enabling the outstanding philosophers of each generation to do more than clarify, by extending and elaborating their thoughts. A volume in the Library of Living Philosophers is not merely a commentary on a philosopher's work: it is a *crucial part of that work*.

Sara G. Beardsworth, Editor of the Library of Living Philosophers since 2015, came to Southern Illinois University, Carbondale in 2004. She received her Ph.D. in philosophy from the University of Warwick, and was previously at Vanderbilt University and the University of Memphis. She publishes in Continental Philosophy, including psychoanalysis and critical theory. Her book *Julia Kristeva: Psychoanalysis and Modernity* received the Honorable Mention for the 2006 Goethe Award for Psychoanalytic Scholarship from the Canadian Psychological Association.
